The Suspected Child Abuse and Neglect (SCAN) Program is a program run by The Hospital for Sick Children (SickKids). SCAN is managed by a team of healthcare professionals at the hospital who offer care, support and assessment to children and teenagers who may have been maltreated, and their families. The SCAN Program provides a link between SickKids and community doctors and hospitals, Children's Aid Societies, police, schools and other community agencies.

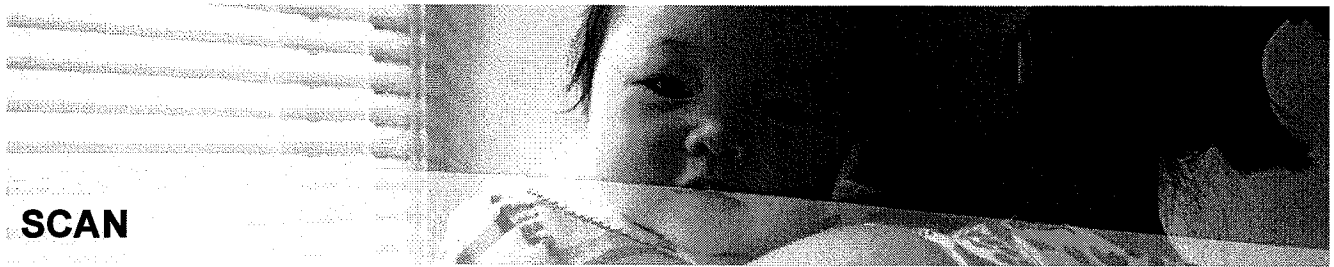

### When and how to contact SCAN

#### When is a SCAN referral appropriate?

- After a referral has been made to the Children's Aid Society, SCAN should be contacted urgently if a child or teenager has been sexually assaulted recently and/or has signs and symptoms related to maltreatment.
- After a referral has been made to the Children's Aid Society, SCAN should be contacted to book an appointment the next business day for non-urgent concerns of maltreatment.

#### How do I contact SCAN?

Phone: 416-813-6275. The main office is open from 9 a.m. to 5 p.m., Monday to Friday.

In the case of an urgent concern there is a SCAN team member on call 24 hours a day. Call 416-813-7500 and ask to be put through to the SCAN team member on call.
