NOTICE OF APPEAL

Karen Smith, Barrister and Solicitor, APPEALS to an Assessment Officer from the decision of the Legal Aid Accounts Officer Review, Legal Aid Ontario, dated , Settlement of Account dated January 10, 2013. Pursuant to Legal Aid Services Act, 1998, and Section 90 of the Courts of Justice Act.

THE APPELLANT ASKS that the judgment be set aside and a judgment be granted as follows:

- 1. Set aside the decision of the Legal Accounts Officer, dated , 201 .
- 2. Legal Aid Ontario shall pay the solicitor's account, dated January 10, 2013, in full.
- 3. Costs on a full indemnity basis.

THE GROUNDS OF APPEAL are as follows:

- 1. Legal Aid Ontario considered the wrong principle in the exercise of its discretion by applying a person of modest means test.
- Legal Aid Ontario considered the wrong principle in the exercise of its discretion based on a test to reasonably allocate the limited legal aid resources.
- 3. Legal Aid Ontario failed to consider the relevant principles in exercising its discretion, by not considering the results obtained on behalf of the client in this particular child protection proceeds. In particular:
 - As a result of the services provided and after the argument of a Contested Motion, the Court expanded the client's access from supervised to unsupervised access. This is an exceptional result in a Child Protection matter and the first step in the children being returned home to their mother.

4. Legal Aid Ontario failed to consider the relevant principles in exercising its discretion by not considering the complexity of this matter in this particular child protection proceeding.

♦ Contested Child Protection proceedings are inherently complex. Resistence of the expansion of a parent's access in the face of Society opposition creates this complexity and thus results in parent's counsel producing the necessary Affidavit evidence to advance their case. In this particular case, mother was successful in arguing before the Court the expansion of her access to the children.

- 2. My audit/opinion on the accounts to Legal Aid Ontario (LAO) from Ms. Karen Smith on behalf of Ms. Jean Black as set out in Exhibit "B" to Ms. Jean Black's Affidavit of January 1, 2014 specifically:
 - ♦ Outline accounts in question.
- 3. Secondly this Affidavit outlines further information for this Court's consideration on the need to reform/modernize the Legal Aid Ontario Tariff for child protection cases and the discretion process for payment of lawyers account.
- 4. Both the audit of Ms. Smith's accounts as noted and the proposed recommendations to Legal Aid Ontario for tariff reform are presented to this court as some minimum thresholds level of funding required to a lawyer willing to take on a child welfare matter to make counsel's representation meaningful and effective.

Legal Experience Historical Background of William A. Sullivan:

- 5. I am a member of the Law Society of Upper Canada, called to the Bar in Ontario in February 1989. I am a member of the Law Society of Upper Canada in good standing and I practice Family Law since 1989.
- 6. I participated in my first child welfare trial CAS matter while in my senior year of law school at Dalhousie Law School in Nova Scotia in 1986 along with Mr. Rollie Thompson who had carriage of the trial Chief Counsel at that time and director of the Dalhousie Legal Aid Program Rollie Thompson.
- 7. In 1987 I articled at Parkdale Community Legal Services Toronto Ontario where I worked primarily in poverty law areas as well as refugee claims. At Parkdale I also had carriage of three child welfare files and began to work in this field in Ontario in 1987 with these files.
- 8. In 1989 with my call to the Bar I opened my own practice in Toronto, Ontario handling refugee claims and family law domestic files and child welfare files.
- 9. Since 1999 I have concentrated my practice entirely on domestic family law files and child welfare files.

- 10. For the first six years of my practice, I also maintained a role as a supervising lawyer with Parkdale Community Legal Services supervisor the students taking that clinic program.
- 11. Over the course of my practice I have had five articling students, two of whom have continued to practice in the area of family law, one in criminal law, one in immigration and one in community (LAO) based advocacy.
- 12. For the past 10 years I have averaged about 30 legally aided files per year, 90% of which are representing parents as parents' counsel in child welfare matters. The balance would be in domestic matters.
- 13. Since 1999 to the present I have also been a Children's Lawyer representing children whose families are involved in the child welfare system before the court and/or representing young parents whose children are before the courts in the child welfare system. When representing Minor Parents before the Courts, the Office of the Children's Lawyer allows Panel Members 40 hours during the first year of the file and 20 hours during the second and each subsequent year. If, however, and prior to exceeding those time allotments, the Panel Member is able to write to their Regional Supervisor for additional hours, provide an explanation as to why you require those hours. My experience as a Panel Member is when I have requested additional hours the Office of the Children's Lawyer has granted the same.
- 14. Over the course of my practice I have argued on average one and a half Motions per month, argued eighteen Summary Judgments Motion trials and averaged one trial a year since 1999 primarily in the child welfare area.
- 15. I have given presentations to lawyers, principally at the 311 Jarvis Family Open Bar Series, in the following areas of work dealing with the child welfare system.
 - Representing parents who have mental health and other disabilities,
 - Representing parents who have drug and alcohol difficulties,
 - ♦ Representing parents whose children have suffered unexplained physical injuries,
 - Representing parents involved with immigration and family law.

16. Attached and marked Exhibit "A" is part of my CV with community presentations from 1999 through to 2012.

Audit of Ms. Karen Smith's accounts:

- 17. I have reviewed the Affidavit of Ms. Jean Black with Ms. Black's permission and the attached Exhibits found in Exhibit "B" to Ms. Black's Affidavit of January 1, 2014. In my opinion the work conducted on behalf of Ms. Black was reasonable and necessary to provide Ms. Black with meaningful and effective counsel to assure that her matter would be dealt with by any Court in Ontario in a fair and reasonable manner. This is based on my experiences noted above in representing parents in child welfare matters and in the review of the situation that Ms. Black and Ms. Smith in turn found herself in while beginning to represent her.
- 18. It is my opinion that the steps taken by Ms. Smith were necessary and proactive for the proper representation of Ms. Black by Ms. Smith to move this child welfare matter forward and to advocate on behalf of Ms. Black with the Society as well as be in a position to argue the facts and law before the Court to achieve meaningful results and avoid litigation drift.
- 19. I underline the following important procedural facts that Ms. Smith had to deal with when she took over in August 2012. These were provided to me through Ms. Smith's office which I believe to be true and my review of Ms. Black's January 1, 2014 Affidavit.
- 20. Ms. Smith's accounts submitted to Legal Aid Ontario cover the work needed to respond to the multiple Affidavits that were never responded to initially when Ms. Smith has taken over the file and Affidavits that she was confronted with after being retained.
- 21. The response and work conducted were necessary for adequate and meaningful and effective representation for Ms. Black and necessary to provide the evidence for the court to make the decisions as it did. Ms. Smith's actions achieved positive and meaningful results for the mother and the children and moved the file out of litigation drift into a meaningful direction.

22. If Ms. Smith had not taken the steps necessary she would not be living up to the standards required by the court of counsel representing parents in these matters from my experience over the years as well Ms. Smith would have been negligent in her representation of a family law client as expected of each and every one of us as family law lawyers by the Law Society of Upper Canada.

Needed Legal Aid Tariff Reform in Child Protection Files:

- 23. Ms. Smith as most, if not all family law lawyers in Ontario who are willing to take up a file and represent a parent on a legal aid retainer (certificate) face the difficulty of doing so within the context or confines of a tariff (block of hours) that are in adequate for conducting child protection litigation file in 2014.
- 24. These hourly tariffs have not been revised and updated for many years.
- 25. Litigation in 2014 in child protection matters present multiple issues, multiple problems, a well founded litigant in the child welfare agency as well as standard and expectations of the Courts for the proper evidentiary base from all sides in a file on which a court must make decisions that have a significant impact on the future of a family and the childrens' relationship to the family.
- 26. I have been a part of discussions and made recommendations to Legal Aid Ontario for the reform of the structure of the legal aid tariff in child protection matters and the discretion process for payment of accounts when a lawyer exceeds the block of hours. In 2009 I along with others presented the following recommendations found in Exhibit "B" to this my Affidavit to Legal Aid Ontario for consideration in improving and modernize the tariff hours or blocks.
- 27. Although changes have been made to the delivery of legal services through Legal Aid Ontario the tariff, in terms of hours, have not been reformed in a comprehensive fashion. Further the method and exercise of discretion in terms of reviewing lawyers accounts that exceed the current tariff have been tightened leaving many family law lawyers wondering why their accounts are not being paid in full for work that is necessary for meaningful and effective representation to assure the process is fair to all.

- 2. I was called to the Bar of Ontario in 1984 and a Member in good standing with the Law Society of Upper Canada. From 1984 to the end of 1985, I was in private practice. From 1986 to November, 1989 I worked at a community legal clinic and was responsible for casework in the area of Landlord and Tenant Law. I have been in private practice since November 1989. Since that time the vast majority of my practice concentrates in the area of Family Law (Domestic and Child Protection).
- 3. Attached hereto and marked as Exhibit "A" to this my Affidavit is a true copy of my up-dated Cirriculum Vitae.
- 4. I have been a Board member of the Family Lawyers Association (F.L.A.) since 2008. I am the current Co-Chair and I am the Chair of the Legal Aid Sub-Committee of the Family Lawyers Association.
- 5. The Family Lawyers Association was established in the mid-1990's in response to the crisis in lack of funding and the inadequacies of the tariff at that time. Issues relating to Legal Aid have remained a major focus of the Family Lawyers Association.
- 6. The Family Lawyers Association Board raised the issue of the inadequacy of the tariff hours in both family law and child protection matters during the consultation session between L.A.O. and our Board about the proposed discretion guidelines. Many of our members raised the same issues during the broader consultation sessions. Our Board requested further consultation about improving the tariff to reduce the need for discretion and L.A.O. representatives indicated that they were open to that. Rather than wait for L.A.O. to initiate consultation, the Family Lawyers Association Legal Aid Sub-Committee developed proposed tariffs for family law and child protection matters and drafted a discussion paper. This discussion paper, which is attached as Exhibit "B" to this my Affidavit was approved by the Board in January, 2013.

This Discussion Paper was presented at an Open Bar Program, Ontario Court of Justice, 311 Jarvis St., Toronto, Ontario in January, 2013. The program title was "The Year in Review". Tom Kelsey, Director of Family Law Services, GTA Region, Legal Aid Ontario, was also a panelist for the program.

- 7. Attached hereto and marked as Exhibit "B" to this my Affidavit is a true copy of a letter, dated April 24, 2013, sent by Victoria Starr, Chair of the Family Lawyers Association enclosing the discussion paper approved by the Board on the issue of tariff reform to the present Attorney General of Ontario. This discussion paper dealt with tariff reform in domestic and Child Protection matters.
- 8. I am the Family Lawyers Association representative on the Operations Committee at the Ontario Court of Justice, 311 Jarvis St., Toronto, Ontario. At our January 23, 2013 meeting, Justice Ellen Murray advised that she was requesting Factums on Summary Judgment Motions. Justice Murray suggested at the meeting that parents' counsel might want to question the Society workers and she had been told that L.A.O. does not allow for such questioning and Factums. Tom Kelsey also attended that meeting and advised those in attendance that there were no additional tariff hours for questioning and the preparation of Factums. Mr. Kelsey advised the meeting that it was up to the individual lawyer to decide as to how to use the hours allotted so they can do Factums or questioning, and of course, there is always discretion. I debated that point with him and advised him that you cannot do all of the work necessary within the available hours and there was no guarantee that any discretion will be paid.
- 9. I make this Affidavit for no improper purpose.

FACTUM

PART I: RELIEF SOUGHT

1. That Legal Aid Ontario attend at the Ontario Court of Justice, 47 Sheppard Avenue East, Toronto, Ontario on a date to be fixed by this Honourable Court to explain Legal Aid Ontario's assistance to Jean Black to have and continue to have the assistance of a lawyer to represent her in the within child protection matter currently before this Honourable Court.

- 2. That Legal Aid Ontario, or the Ministry of the Attorney General of Ontario, provide Ms. Black with sufficient funds to cover reasonable fees and disbursements of counsel in order to continue to represent her in the current Protection Application presently before this Honourable Court.
- 3. Costs on a full indemnity basis.

PART II: THE FACTS

4. Outline the Facts of your particular case.

PART III: THE LAW

- 19. Every one has the right to life, liberty and security of the person and the right not to be deprived thereof except in accordance with the principals of fundamental justice.
 - Canadian Charter of Rights and Freedoms, Section 7.
- 20. It is settled law that child protection proceedings attract for both parents and their children the protections of Section 7 of the Canadian Charter of Rights and Freedoms.
 - New Brunswick (Minister of Health and Community Services) v. G.(J.) [1993] 3. S.C.R. 46 (S.C.C.);
 - Children's Aid Society of Toronto v. J.R. [2003]
 O.J. No. 2095 (Ontario Court of Justice)
- 21. The Government of Ontario has not revised the Regulations to the Legal Services Act since 1999 to ensure proper hours are allotted to represent parents in contested Child Protection Proceedings.

- 22. On November 26, 2012, Legal Aid Ontario instituted policies and procedures which in effect restrict the Plan's ability to pay lawyers for parents in a contested Child Protection proceeding.
 - Discretion Guidelines, Legal Aid Ontario, November 26, 2012.

- 23. Individual rights in the Charter such as Section 7 provide a basic legal protection that will be safe guarded in dealing with the State. These rights are designed to protect an individual (parents and children) and to ensure simple fairness should he or she be subject of legal proceedings involving the State.

- 24. The Supreme Court of Canada has indicated that a parent's right is protected by Section 7 of the Charter to raise their children without interference from Child Protection authorities within limits to these rights. The limits and State intervention is to be considered as necessary to protect the well being of a child, but such intervention must take place in accordance with the principles of fundamental justice and imbedded in those principles is a duty of fairness.

- 25. Canadian Courts have considered the issue of state funded legal representation since the Supreme Court of Canada's ruling in New Brunswick (Minister of Health and Community Services) v. G.(J.) [1999] 3 S.C.R. 46 (S.C.C.)

- 26. Legal Aid Ontario has refused to provide counsel to a parent who is a litigant before the Child Protection Courts based on internal policies of the Plan. As stated by Justice O'Connell in Children's Aid Society, Region of Halton v. K.C.M., N.M. et al [2012] ONCJ 382 (Ontario Court of Justice). This refusal was based

on internal policies of Legal Aid Ontario and it is submitted on behalf of the Respondent mother that the current internal policies (length of time for Legal Aid Ontario to exercise its discretion, appeals of settlements of accounts) result in an infringement of the Respondent mother's Section 7 rights under the Canadian Charter of Rights and Freedoms. It is the Respondent mother's position that the existence of these internal policies at Legal Aid Ontario and the Government of Ontario's inaction on tariff reform hours allotted for Children Protection cases has resulted in an infringement of the Respondent mother's Section 7 rights under the Canadian Charter of Rights and Freedoms.

As stated by Justice O'Connell in Children's Aid Society, Region of Halton v. K.C.M., N.M. et al [2012] ONCJ 382 (Ontario Court of Justice):

"K.C.M. needs counsel and she has a constitutional right to counsel in this proceeding. In my view, this Court has jurisdiction to make an Order appointing publically funded counsel in a child protection proceeding, in light of the Supreme Court of Canada's decision in New Brunswick (Minister of Health and Community Services) v. J.G. 1999 CANL11653 (S.C.C.)..... In that case, the Court held that the principles of fundamental justice entitle a parent involved in child protection proceedings to a fair hearing, which may include a right to be represented by publicly funded counsel where this is necessary for effective presentation of the parent's case....."

REPLY FACTUM

- Charter rights are paramount in situations where the State intervenes in parties parenting of their children and 1. this is the issue before the Court.
- The mere fact that the Respondent mother is represented by counsel on a legal aid certificate is not a complete 2. answer to the alleged Charter infringement. As stated by Meiklem J. in J.W. v M.E.S. [2000] B.C.J. No. 985 at paragraph 14:

"I do not accept the argument advanced by the Attorney General that, as a matter of principle, if there is legal aid coverage and, therefore, counsel available, that is the end of the inquiry. There is obviously some minimum threshold level of funding required to make the provision of counsel meaningful and effective to ensure the fairness of the hearing. For example, if there was no funding for preparation in a case which required extensive preparation, providing counsel at the hearing alone would be perfunctory and probably would not ensure fairness."

J.W. v. M.E.S. [2000] B.C.J., No. 985, Supreme Court of British Columbia

3. Child Protection matters are complex cases, particularly where the Society (State) intervenes and apprehends children from their parents' care. Not only is there a risk to the parents' Section 7 rights but there is a risk to the children's Section 7 rights. In such cases there is the potential for the severance of the parent / child relationship.

4. All steps taken by Respondent mother's counsel (independent of the Respondent father) were necessary in order to ensure that the hearing of her case was presented to the Court in an effective manner. The steps taken were necessary to ensure that the file moved out of litigation drift and moved in a meaningful direction.

5. All appeals have been exhausted by Respondent mother's counsel at Legal Aid Ontario of her interim account dated January 10, 2013.

6. The Court has held that in order to establish a Charter breach it must be established that the cap on preparation would probably impede the effectiveness of counsel to the extent that a hearing would be rendered unfair due to the lack of adequate representation. There also needs to be some minimum threshold level of funding required to make the provision of counsel meaningful and effective to ensure the fairness of the proceeding.

7. The issue before the Court is not whether the hourly rate paid to the Respondent mother's counsel is an adequate hourly rate. The issue before the Court is whether or not the cap on the hours allowable and the corresponding uncertainty of discretion will impede the effectiveness of Respondent mother's counsel that a hearing would be rendered unfair due to a lack of adequate representation. As stated in R.v. G.L., there also

needs to be a minimum threshold level of funding required to make the provision of counsel meaningful and effective to ensure the fairness of the proceeding.
